



Applicable Administrative Fees

Application for Registration	\$125,00
-------------------------------------	-----------------

Non-refundable application fee payable with each application for registration.

This fee is in addition to any prescribed registration fees or dues applicable to the registration category.

Applies to new applications, including Full Practice, Non-Clinical, Provisional, and other applicable registration categories.

Application for Student Affiliate	\$100,00
--	-----------------

One-time non-refundable application fee of \$100.00 must accompany the application for student registration which will remain in effect for the duration of the program that the applicant is enrolled in.

Application/Request for Register Change	\$125.00
--	-----------------

Non-refundable application fee of \$125.00 must accompany each application/request for register change.

Fee applied in addition to the prescribed dues (if applicable). Ex: Full Practice to Non-Clinical, etc.

Application for Reinstatement	\$125,00
--------------------------------------	-----------------

Non-refundable application fee of \$125.00 must accompany each application for reinstatement. This fee is in addition to any prescribed registration fees or dues applicable upon reinstatement. Applies to registrants who resigned while in good standing and are eligible to apply for reinstatement.

Application for Reinstatement due to Delinquency	\$225,00
---	-----------------

Non-refundable reinstatement fee payable in addition to any prescribed registration fees or dues for individuals whose registration has lapsed due to failure to renew by the required deadline and/or failure to resign in good standing. This fee includes the applicable late renewal fee, reinstatement fee, and administrative processing fee.

Application for Reinstatement due to Suspension / Disciplinary Action	\$250,00
--	-----------------

Non-refundable reinstatement fee payable in addition to any prescribed registration fees or dues for individuals applying for reinstatement following an enforced suspension and/or disciplinary action. This fee includes applicable administrative and reinstatement processing fees.

Annual Renewal Late Fee	\$75,00
--------------------------------	----------------

A non-refundable late fee is applied to registrants' renewal invoice when registrant fails to complete renewal requirements by the prescribed renewal deadline.

Non-sufficient Funds (NSF)	\$40,00
-----------------------------------	----------------

A non-refundable fee applied when a payment is returned due to insufficient funds. The registrant must submit payment of the NSF fee and any outstanding prescribed fees or dues within 10 business days using an alternative payment method.

Payment Return Fee	\$25.00
---------------------------	----------------

A non-refundable administrative fee applied to requests for refunds resulting from overpayment due to administrative error or registrant negligence.

NOTE - Administrative fees are:

- non-refundable unless otherwise specified by the Board.
- are payable in addition to any prescribed registration fees, annual dues, or other fees established under applicable legislation, regulations, bylaws, or policies.
